



## **Countless Unions, Business Advocacy Groups Stand Behind New RIN Legislation to Support Our Nation's Refiners**

A diverse group of labor unions, business advocacy groups, and other community groups have endorsed legislation introduced by U.S. Senators Bob Casey (D-PA) and Chris Coons (D-DE) and Representatives Brian Fitzpatrick (R-PA-1), Donald Norcross (D-NJ-1), Mary Gay Scanlon (D-PA-5), and Brendan Boyle (D-PA-2) that would stabilize the unpredictable and unsustainable price of Renewable Identification Numbers (RINs) under the Renewable Fuel Standard (RFS). This bill would protect tens of thousands of family-sustaining refinery jobs, lower costs for consumers, and support America's energy independence.
